4. Along with the Milk & curd indent, You have to pay the entire amount in advance after which the production will be taken & Milk & Milk products will be issued.

5. You have to ensure that you to make payment every day in advance as per the indented quantities. On holidays an advance has to be maintained conforming to the indents.
6. You are responsible for return of crates on regular basis.
7. The indented quantity has to be lifted compulsory & there is no provision for return of Milk & curd.
8. Under any circumstances if advance payment is not received Milk and Milk Products will not be issued.
9. There should not be any encroachment of the sales points into borders of Karnataka
